The CRA offers a volunteer based program called the Community Volunteer Income Tax Program (CVITP) that works with community volunteer organizations across the country to provide:

• T1 returns prepared for free for eligible individuals by volunteers trained by CRA

- Low income
- Simple tax situation
- Unable to complete your return yourself

- Between February and April each year
- Some tax clinics operate year round
